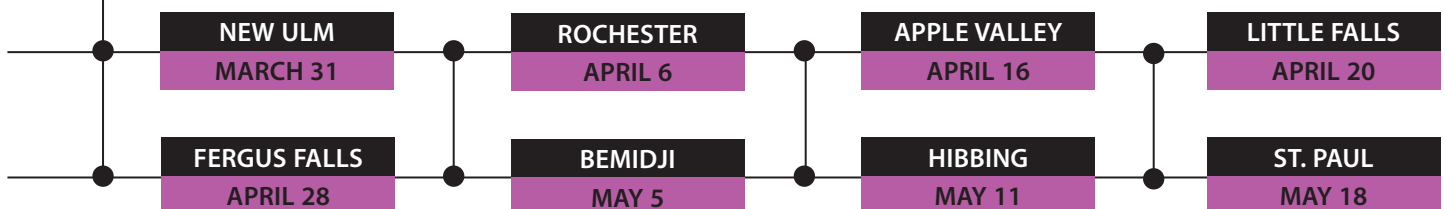

● **About the Forum** – Prescription drug abuse is a growing problem in Minnesota, as well as nationally. To advance the understanding of the multifaceted nature of this issue and the extent to which it is a concern in Minnesota, the Alcohol and Drug Abuse Division of the Department of Human Services, together with the Minnesota Prevention Resource Center, are presenting these regional forums. The forums will benefit prevention professionals, law enforcement, addiction counselors, public health personnel, educators, pharmaceutical personnel, nurses and others who are interested in this important public health issue.

● **Participant Objectives**

- 1) identify patterns in prescription and OTC drug abuse by frequency, gender, age group and race
- 2) identify the symptoms of intoxication and withdrawal from the three common categories of abused prescription medications
- 3) gain knowledge into prevention strategies specific for prescription medications
